Annual Operating Plan – Dwayne & Clint

- Generally maintaining the parking areas, re-opening pit toilet (closed for covid/staffing), installing new signage.
- Road maintenance including mowing and some ditching, graveling and rehabilitation of roads.
- Repairs to Indian Stream Road are almost complete. Appx \$40,000 for emergency repairs.
- Prepped all roads for logging per the spring meeting with the landowner.

Discussion

• Has the endowment disbursement been increased? Not yet.

Motion

• The committee shall write a letter to the Commissioner to encourage increasing the endowment disbursement. Seconded by Charlie Levesque. All in favor.

Capital Budget Plan – Dwayne & Clint

• 53 miles have been prepared for the placement of gravel.

Discussion

- Should culverts be upsized on the feeder streams?
 - Didn't lose many culverts on the CLH after the most recent storms. DNCR has been replacing them over time as road upgrades are made.
- The next 5-year plan should have an analysis to determine which culverts should be replaced versus upgraded to bridges. The crossings are the most important facility to maintain roads and access.
- Capital funds are approved for a biennium FY24-25 (July 1, 2023-June 30, 2025). Funds can be rolled over to the next biennium if unspent.
 - Gene recommends sending occasional updates to the House/Senate to keep them up to date.
- The \$1.5 million exceeds the contracting ability of DNCR and the contracts may have to be administered by the DAS Division of Public Works.
- DES would like to partner on contracts for repairs to Cedar Stream Road.

Motion

• Recommend \$200,000 is kept for non-graveling projects such as culvert upsizing, bridges and related work. Proposed amendment to the motion to increase to \$500,000. Seconded by Eric Stohl. 7 in favor one opposed.

Road Management Plan

- Overdue per the easement.
- What does the department think can be done? Request a timeline for the plan at the fall meeting.

Other Business

- Request an accounting of OHRV funds expended and projects done on the CLH property at the fall meeting.
- The Great River Hydro crossing agreement is being passed between the parties.
- The committee requests pre-meeting review materials prior to the meeting so they can be prepared to ask questions and clarification.
