Overview

The Department of Natural and Cultural Resources (DNCR) Volunteer Program oversees volunteers working in New Hampshire's state parks, state forests, and state historic sites. This statewide program spans two Divisions within DNCR, the Division of Parks and Recreation and the Division of Forests and Lands.

At the beginning of September 2022, Phil Bryce retired as the Director of NH State Parks after serving more than a decade in the position. While reflecting on his time as Director and the accomplishments that took place over the last 10 years he said, "these transformations would not have occurred without the active support of elected officials at all levels of government, partners, volunteers, local communities, other state agencies, and our division employees."

Brian Wilson was confirmed by the Governor and Council as the new Director of NH State Parks in October of 2022. Wilson has a strong history of working within the recreation industry in New Hampshire, including as NH State Parks' Seacoast Regional supervisor and as a recreation program supervisor in Dover. Throughout his career, he has also held several positions at local and statewide parks organizations in Connecticut, most recently as assistant director of Connecticut State Parks. At his confirmation he said, "NH State Parks have a profound positive impact on the lives of millions of residents' and visitors—and I am no exception... I look forward to working with the amazing State Park's team, the DNCR, and the communities that work together to contribute to the stewardship for these special places."

The Cohos Trail Association and Seacoast Science Center continue to be a reliable source of volunteer opportunities where the public at large can engage with State Parks hands-on. Major community efforts, like we've seen surrounding the re-construction of the Nansen Ski Jump have shown that people are still very much community-minded and want to contribute their skills and time toward something positive.

DNCR volunteers donated a total of 20,038 hours of volunteer service to state lands in 2022. This impressive amount of time and effort is equal to a total donated value of \$600,138.00. This number is not only a quantitative way to express the dedicated volunteers, but it also reflects the trend of increased reporting quality— despite a gap in staffing while the volunteer program manager role was vacant and. Nonetheless, it is clear that DNCR volunteers provide a variety of invaluable services to New Hampshire's state lands, visitors, and staff. The agency is looking forward to another successful year in 2023 now that the volunteer manager role has been filled once again.

In Remembrance

Richard Freeman "Dick" Hamilton

February 13, 1936 - July 20, 2022

Dick was considered to be the father of modern White Mountains tourism. When the Old Man of the Mountains fell, he was devastated and made it his mission to create a lasting and fitting monument to his "Boss." He and a dedicated group of volunteers known as the Old Man of the Mountain Legacy Fund, made it their mission to raise funds through private donation and construct what today is known as Profile Plaza located in Franconia Notch State Park. This meaningful remembrance allows visitors to experience seeing the Old Man in his former glory.



Ray Jackson

August 9, 1940 - October 9, 2022

Ray Jackson joined the Trailwrights non-profit organization in the second year of its existence. He was president of Trailwrights from 1997 to 2014 and was full of great ideas and suggestions for the organization and their work at Franconia Notch State Park and Fox Forest. Ray was also a dedicated trails community volunteer with the Society of the Protection of NH Forests (SPNHF) and a long-time member of the Statewide Trail System Advisory Committee . Ray leaves behind a legacy of NH hiking trail improvements that includes countless water bars, stone steps, drains, bog bridges, and the annual brushing of trails.



Sanford "Sandy" Young

April 28, 1961 - October 4, 2022

Sandy Young began working for the State of NH on May 14th, 1993. He worked as the Lake Francis Park Manager in the summers and spent his winters with the Trails Bureau. On June 28th, 2002 Sandy was promoted to the Regional Supervisor for the Great North Woods Region which includes overseeing all the state parks, waysides, and campgrounds in the North Country and the Connecticut Lakes Headwaters land. His contributions to NH State Parks and the trail systems are immeasurable and will live on for generations to come.

Single Day Groups = Groups that enter into a short term agreement with DNCR to perform a single project or event.


Individuals = Individual volunteers who do not work on behalf of a Friends group or organization.

- **20,038 volunteer hours** were submitted for the 2022 calendar year, this equates to an estimated value of \$600,138.00 in donated volunteer labor and time on DNCR land.
- Over 1,200 individuals volunteered their time and effort on DNCR land in 2022.
- 6 long-term Friends groups entered into new volunteer agreements with DNCR in 2022. These groups include: Weeks State Park Association, Wentworth-Coolidge Commission, Enriched Learning Center, New England Mountain Bike Association: Seacoast Chapter, NH Mushers Association, Friends of Forest Lake Trails
- 18 long-term Friends groups renewed their volunteer agreements. These groups include: Access Fund, Appalachian Mountain Club, Belknap Range Trail Tenders, Coos Cycling Club, Friends of Fort Constitution, Friends of Fort Stark, Friends of the Ledges, Friends of Friends of Pisgah, Friends of Concord Lake Sunapee Rail Trail, Monadnock Climbers Association, Northwood Meadows State park, Old Man of the Mountain Legacy Fund, The Cohos Trail Association, Surfrider Foundation, Sunapee-Ragged-Kearsarge Greenway Coalition (SRKGC), Trailwrights, White Mountain National Forest, Cooperative Maintenance Agreement with Mount Sunapee Report and SRKGC
- The Department **provided liability insurance** that covered approved volunteer activities for 13 different non-profit Friends groups and non-motorized trail maintenance organizations whose work spanned 21 different state reservations.
- The Department held **2** free volunteer chainsaw safety certification classes for DNCR volunteers at Bear Brook State Park and Milan Hill State Park. DNCR volunteers can be granted approval to use a chainsaw on state lands if they have an up-to-date chainsaw certification on file with the Volunteer Program Manger. Approved DNCR volunteers are permitted to cut downed debris that is not under pressure or strain.
- **DNCR volunteers provided a variety of services** throughout the state including grounds maintenance, trail work, GPS data collection, invasive species removal, search and rescue, and so much more.





- The Department held Bear Brook State Park Trail Cooperative and Pisgah State Park Trail Cooperative meetings in March and April of 2022. These meetings brought together state staff and user group representatives to discuss strategies and share information on how to best cooperatively manage the trail system in each park.
- In April the Department held three Trail Clean-up Days across the
 State. At Bear Brook State Park 37 volunteers donated 111 hours, at
 Pisgah State Park 4 volunteers donated 14 hours, and at Blue Job
 State Forest 20 volunteers, including the Trailwrights volunteer group,
 donated 80 hours. Volunteers cleared the trails of fallen debris and
 recorded trail issues for staff to address at a later date.



- Old Man of the Mountain Legacy Fund installed their second batch of engraved brick pavers at Franconia Notch State Park's Profile Plaza.
 Funds raised by these pavers goes towards the long-term maintenance of the plaza.
- Friends of Fort Stark held a volunteer day every Wednesday at Fort
 Stark. Work included grounds maintenance, maintaining displays
 inside the museum/visitor center, mending holes cut in the fencing
 around the bunkers, painting over graffiti, and opening and closing the
 gate to the parking lot.
- Single Day Volunteer Groups continue to work with the Blue Ocean Society's and the Seacoast Science Center for volunteer clean-ups from state beaches and invasive species control with the Rockingham County Conservation District
- Trailwrights held 9 work days at Franconia Notch State Park
 performing trail work at Artists Bluff/Bald Mountain and Mount
 Pemigewasset and the Fox Research and Demonstration Forest



AMC rebuilt a 0.7 mile loop using RTP funds in order to make the trail fully accessible for wheelchair users.

- Volunteers at Miller State Park helped to paint buildings and plant native plant species in an ongoing effort
 to beautify the summit. The culmination of these years long efforts were celebrated with a ribbon cutting
 ceremony attended by Senator Sununu and Commissioner Stewart of the Division of Natural and Cultural
 Resources.
- Friends of the Wapack and Trailwrights worked together to repair extensive trail damage on the Beebee
 trail at Temple Mountain State Reservation (across the street from Miller State Park). The damages were
 caused by illegal motorized use on the trail. Repairs included fixing the damaged bod bridges, cutting out
 damaged trees, laying stepping stones in a muddy area, and cleaning and adding new drainage.
- The **Appalachian Mountain Club (AMC)** rebuilt a 0.7 mile loop to be fully accessible on the AMC property adjacent to Cardigan Mountain State Forest with funds from the Recreational Trails Program (RTP) grant. Several bridges were replaced, the trail was reimagined and graded, and added picnic areas and tables.
- The Cohos Trail Association rerouted part of the Cohos trail in the Connecticut Lakes Headwaters Working Forest in order to get the trail off the existing road and ATV trail. Funds from the RTP grant program were used to hire the Northwoods Stewardship Center (youth crew) in order to create the 2.2 miles of new trail.
- The **Cotton Valley Rail Trail Club** used RTP funds to maintain the 12 mile stretch of rail trail from Brookfield to Wolfeboro. Work included brushing and clearing overhanging canopy, installing beaver deceivers to address drainage issues, and installing a 84' guard rail to prevent cars from parking over the rails.
- White Mountain National Forest Trailhead Steward Volunteer Program ran from mid-May through mid-October at the Old Bridal Path/Falling Waters trailhead at Franconia Notch State Park. Trailhead volunteers contacted 11,107 hikers at the trailhead. 1,532 hikers changed plans (went back to the car for more gear did a different hike, decided not to hike) based on volunteer trailhead steward advice.

- Rusty Bastedo retired as President of the Wentworth-Coolidge Commission after serving 25 years on the board. His dedication to preserving the Wentworth Coolidge Historic Site can be seen in the various preservation projects he was involved in and the various ways he was able to raise funds for the Commission.
- Society for the Protection of New Hampshire Forests (SPNHF) held
 the 16th annual Monadnock Trails Week at Monadnock State Park. 42
 volunteers contributed approximately 550 hours of trail work on the
 White Arrow trail, the Marlboro trail, at trailheads, and on Gap Mountain. Project ranged from trailhead maintenance to technical rockwork.
- Volunteer Jed Piatt organized 3 volunteer work days in the climbing areas at Pawtuckaway State Park. A total of 20 volunteers cleared debris at Round Pond lot and Shaw trail.
- Master Gardeners volunteered 550 hours over the span of 3 weeks at the State Nursery helping staff to sort and package plants.
- The Weeks State Park Association (WSPA) and The Cohos Trail Association (TCTA) constructed a new trail at Weeks State Park in honor of the former WSPA President and park manager Pat Nelson. This trail creates a new loop experience at the summit of the park that leads from the carriage house to the north overlook.

- Volunteers at **Belknap State Forest** donated their time to opening and closing the gate on the property from May through November to allow for public access. Volunteers have been assisting the Department with gate duties since the 1990s which has led to a noticeable decrease in vandalism on the mountain.
- Cardigan Highlanders Volunteer Trail Crew performed bi-monthly trail work days at Cardigan Mountain State Forest, Mount Sunapee State Park, and Mount Kearsarge State Forest (Winslow & Rollins State Parks). Work included building rock steps, building bog bridges, working on drainage, barricading, and brushing in trails.
- **Belknap Range Trail Tenders** held 6 work days at **Belknap State Forest**. Work included placing rock steps, enlarging water bars, working on drainage, and quarrying rocks for future trail work.
- Friends of Pisgah contributed a total of 1,220 hours of volunteer service maintaining the many trails and roads of the 13,300-acre Pisgah State Park. The FOP, in cooperation with equestrian groups developed a experimental technique to prevent slippery bridges which has been adopted by the DNCR as a new practice
- The Cohos Trail Association completed 2.2 miles of new trail between Coleman State Park and the Lake Francis Trail, and aided Maggie Machinist in repairing a bridge on Percy Peaks.

Looking Ahead

2023 Volunteer Program Initiatives

- **Non-motorized Trail Specialist** The Department has hired a non-motorized trail specialist that will be under the Trails Bureau. This position will be working closely with the Volunteer Program to support the needs of our non-motorized trail volunteer groups.
- Chainsaw Classes The Volunteer Program will continue to offer free DNCR chainsaw safety classes for DNCR volunteers. These classes are taught by a Division of Forests and Lands instructor and offered in various locations across the state. Contact the Volunteer Program Manager if you are interested in attending a future DNCR chainsaw safety class.
- Annual Meetings The Volunteer Program is working to host annual meetings for all volunteers in the
 spring and fall of each year. The purpose of these meetings will be to share what volunteers are working on
 across the state, provide an opportunity to learn from professionals and peers, and to network and thank
 our amazing community.
- Volunteer Activity Passes The Department has started to use a NH
 State Parks Volunteer Activity Pass to make it easier to provide free
 admission to parks that have a day-use fee for DNCR volunteers en gaged in approved volunteer activities. Contact the Volunteer Program
 Manager to request an activity pass.



- Volunteer Program Tool Trailers Department volunteers under an active volunteer agreement are eligible to borrow the trailer and/or tools from the trailer. Contact the Volunteer Program Manager to reserve the use of this resource.
- **Volunteer Program Handbook** A handbook of volunteer policies, protocols, and FAQs as a resource for volunteers and staff is under development.
- **Volunteer Recruitment** The Volunteer Program is looking to further assist volunteer groups with recruitment through promoting groups on NH State Parks social media accounts and advertising upcoming work days.
- Cooperative Trail Group Meetings Biannual meetings are scheduled to be held with state staff and user groups at Bear Brook State Park and Pisgah State Park to collectively maintain and improve the trail system in each park. Staff are working to form similar working groups for Mount Sunapee State Park and Pawtuckaway State Park.
