## SCA New Hampshire Conservation Corps 2020 Field Season Report The Student Conservation Association in Partnership with NH Department of Natural & Cultural Resources—NH Parks



### Introduction:

During the 2020 season the SCA NH AmeriCorps Conservation Crews completed service projects at two NH State Parks locations — Bear Brook State Park and Franklin Pierce Homestead Historic Site.

Due to the Covid-19 pandemic, the program concluded prior to the start of the planned field season and ultimately allowed for only a few weeks of service in parks. While the field-based service only lasted a short time, all ten interpretive ranger members joined the 17 conservation stewards to tackle the campground projects as a large team.

### Accomplishments:

After completing the education season and doing alternative service tasks during the early stages of the pandemic, members were excited and energized to get out and do manual labor service projects. We had an excellent group with a driving work ethic that completed service during mostly rainy cold spring days.

Together we improved 9.5 acres of land in NH Parks. At both Bear Brook State Park and Franklin Pierce Homestead Historic Site, crews worked to prepare the sites for spring openings and visitors. This work consisted primarily of wood and debris removal, limbing and cutting brush back, raking, and in the case of the Bear Brook campground, making a massive burn pile that the crews really enjoyed.

Here is a summary of the various projects we completed in partnership with NH State Parks. Included is service projects completed at two park locations and Spruce Pond Camp improvements.

### *Property & Grounds Maintenance & Improvement*

- 413,820 sq. ft. of Natural Debris Removal from camp sites, open spaces, around park buildings
- Cleared 101 Campsites
- 500 sq.' of Lake Shoreline Cleared
- 50+ Trees Limbed, Topped, & Stump Cut
- 480 sq. ft. of Picnic Tables Painted



### **Spruce Pond Camp Maintenance**

- 19,000 Sq. Ft. of Building Roof Maintenance/Sweeping at Spruce Pond Camp
- 54 Hours Snow Removal from Roofs Storm windows

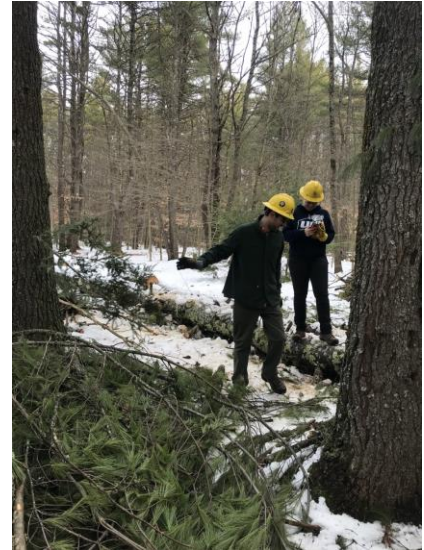
